

At the Bronkhorstspruit biogas plant, 40,000 tonnes of cattle manure and a further 20,000 tons of mixed organic waste per annum is fed into two anaerobic digesters that produce the biogas feedstock for a combined heat and power application.

Power will be supplied from the 4.4 megawatts (MW) installed capacity Bronkhorstspruit Biogas Plant

According to the German automaker, 25-30% of the facility's electricity requirements is generated from renewable sources.





## **Indonesia - Organics**





Palm oil mill effluent or tapioca process residues can be treated to generate energy for local processing.

Ammonia stripping technology can also be included to ensure output of clean water.







A Bioenergy Action Plan is being developed by the Ministry of Energy aims at eliminating the use of wood for cooking in all public institutions by 2028.

The majority of the population in the rural area cannot afford gas or charcoal so they use wood from local trees which are not re-planted


